DOLAN and COLEMAN FIRES

CLOSURE ORDER REMAINS IN EFFECT FOR THE MONTEREY RANGER DISTRICT

The Monterey Ranger District of the Los Padres NF remains closed under Closure Order Number 05-07-51-20-22. This closure order is in place to provide for visitor and firefighter safety. Additionally, emergency fire restrictions are in effect until **October 30**.

TODAY:

Coleman Fire

Crews will continue mop-up and to patrol for any hot-spots near the fire perimeter.

Dolan Fire

Patrols will continue to observe for any smoke or flame from any green islands. Repair work focuses on Cone Peak, the Plaskett and South Coat Ridge Roads as well as the area around Arroyo Seco. Repairs to drainage control structures continue along the Nacimiento-Fergusson Rd.

YESTERDAY:

Coleman Fire

Fire crews made progress in putting fireline around the fire today. Some heavy logs were putting off smoke on the interior of the fire, but there is no threat to the fireline.

Dolan Fire

Graders and dozers continued to repair roads and control lines on the south portion of the fire. The fire transitioned from a Type 2 to a Type 3 Incident Commander on Sunday afternoon in anticipation of the Eastern Area Silver IMT demobilizing at the end of the week.

WEATHER:

A very dry air mass will allow for much lower humidity than yesterday. Values may be as low as 17%. Wind gusts are expected, but should pose no threat to the firelines. Temperatures are expected to be in the 60s to 70s.

SUMMARY:

The Coleman fire started at approximately 1200 pm on October 18, 2020 and is estimated at 574 acres with 70% containment.

The Dolan Fire started on August 18, 2020 on the Monterey Ranger District of the Los Padres National Forest. The fire has grown to 124,924 acres and is 98% contained. **The Monterey Ranger District remains under a Closure Order for visitor and firefighter safety. The Nacimiento-Fergusson Road remains closed.**

- The Monterey Ranger District of the Los Padres NF remains closed under Closure Order Forest Order Number 05-07-51-20-22.
- Nacimiento-Ferguson RD is closed to all traffic (public and residential) from Highway 1 to the Fort Hunter Liggett base boundary line (16 miles inland).

SAFETY:

A Temporary Flight Restriction (TFR) is in place above the Coleman and Dolan fire area.
